- 1.** Heard Mr. S. K. Singh, the learned senior counsel assisted by Mr. A. Ganguly, the learned counsel for the petitioner, who submits that both the above mentioned Civil Revision Petitions are heard in part and it has been substantially heard.
- 2.** He submits that in view of the pendency of this Civil Revision Petition further proceeding of the Title Suit No. 11/2010 and Title Suit No. 19/2011 pending before the Court of learned Civil Judge, Junior Division, Lakhimpur are required to be stayed in view of the pendency of these Civil Revision Petitions.

3. As the above noted Civil Revision Petitions already heard in part, there is every likelihood of disposal of these petitions expeditiously.
