Sir

In continuation of this Department’s letter under reference I am directed to say that necessary instruction was given to Assam Public Service Commission vide letter No. E – 249812 /68 Dtd. 08/05/2025 to insert the Provision of 4% reservation for PwD candidates with respect to the advertisement to the post of Inspector of Schools/DEEO/Dy. Director under the light of the Persons with Disabilities Act, 2016. In regard to this Department’s letter under reference APSC vide Letter No.22.PSC/DR-79/12023/2024 Dtd 16th May 2025

requested to provide with a detailed breakup of posts reserved for PwD in accordance with the OM vide No. ABP 180/2017/211 dated 21.5.2022, reflecting the 4% reservation. In this regard this Department is determining the points and revisiting the previous register for inclusion of the 4% PWDs.

In view of above you are requested kindly to request to seek time from the Hon'ble court for full compliance as in principle it is complied as per direction of the Hon'ble Court.
