Mr. M.H. Ahmed, the learned counsel for the petitioner, prays for and allowed to make corrections in the cause title of the case, under his own hand and signature.

The petitioner was engaged as a Junior Instructor (Electrician) on 15.5.1994 (Annexure-2) at the ITI, Srikona in Cachar District and his claim is for *regularization* of his service at the ITI.

The learned counsel, Mr. M.H. Ahmed refers to the earlier writ petition filed by the writ petitioner i.e. the WP(C) No.6010/1999 and the Court's order dated 12.3.2017 (Annexure-14), in that case. He also refers to the writ petition filed by the similarly situated petitioners, which led to the analogous order of this Court passed on 8.1.2013 (page-43), in the concerned three writ petitions.

In view of above, let notice returnable in 6 weeks, be issued. Mr. S.S. Roy, the learned Govt. Advocate, accepts notice for respondent No.1. Notice on the respondent No.2 be served through Mr. B. Gogoi, the learned standing counsel for the Finance Department. The notice for the respondent Nos.3 & 4 is received by Mr. S.P. Das, the learned standing counsel for the Skill, Employment & Entrepreneurship Department. Necessary extra copies be furnished to all three lawyers.
