Heard Mr. K. Boruah, learned counsel for the petitioner.

In this petition under Section 438 read with Section 442 of the Bharatiya Nagarik

Suraksha Sanhita (BNSS), 2023, the petitioner has challenged the judgment and order dated 05.04.2021, passed by the learned Additional Chief Judicial Magistrate, Golaghat, in CR(NI) Case No.28/2016, convicting the petitioner and sentencing him to pay a compensation of Rs.6,00,000/- under Section 138 of the N.I. Act and to undergo simple imprisonment for 6(six) months, in default of payment of compensation and also the judgment and order dated 25.02.2026, passed by the learned Sessions Judge, Golaghat, in Criminal Appeal No.26/2021, by which the learned Appellate Court has upheld the judgment and order of conviction.

Perused the petition and the documents placed on record and also perused the impugned judgment and order dated 05.04.2021, passed by the learned Additional Chief Judicial Magistrate, Golaghat, in CR(NI) Case No.28/2016 and also the judgment and order dated 25.02.2026, passed by the learned Sessions Judge, Golaghat, in Criminal Appeal No.26/2021.

Issue notice to the respondent, returnable within 4(four) weeks.

Step be taken by speed post and also by usual process within a week from today.

Registry shall call for the record from the TCR from the Court of learned Additional Chief Judicial Magistrate, Golaghat and also the record of the learned Appellate Court in Criminal Appeal No.26/2021.
