In Cont. Case (Crl.) No.1/2025, Mr. P.K. Goswami, learned senior counsel, assisted by Mr. D.K. Das, learned counsel has put in appearance on behalf of the respondent No.1. He prays for 6(six) weeks time to file counter to the contempt petition.

Time prayed for is granted.

The respondent No.1 in Cont. Case (Crl.) No.2/2025 is present in person and has submitted that reply to the contempt petition is filed on 08.05.2025.

Mr. K. Gogoi, learned counsel appearing on behalf of Mr. D. Saikia, the petitioner-in-person in both the contempt cases prays for some time to go through the contents of the reply to the Cont. Case (Crl.) No.2/2025 filed by the

respondent No.1. He prays for liberty for the petitioners to file response to the counter affidavit filed by the respondent No.1 in Cont. Case (CrI.) No.2/2025, if necessary.

Mr. N. Gautam, learned counsel appearing for the respondent No.2 in both the contempt cases has produced before this Court an order dated 28.04.2025 passed by the Hon'ble Supreme Court in SLP (CrI.) No.6225-6226/2025.
