Heard Mr. D Hussain, the learned counsel appearing for the petitioner. Also heard Mr. Bankim Sarma, the learned Additional Public Prosecutor appearing for the State of Assam.

2. This is an application under Section 528 of the BNSS, 2023 in respect of **Special (N) Case No. 37/2025** pending in the Court of the learned **Special Judge, Sribhumi**.

3. The petitioner **Burhan Uddin** has been shown as an absconder in the charge sheet alleging offences under the provisions of the NDPS Act. Therefore, the petitioner apprehends that if he appears before the trial court, he will be remanded to judicial custody.
4. Mr. Sarma has pointed out that commercial quantity of narcotic drugs were seized in this case, and therefore, he has objected to this petition.
5. Mr. Hussain has submitted that the petitioner is interested in facing the trial and therefore, he should be given adequate opportunities to that effect.
6. I have considered the submissions made by the learned counsel of both sides.
7. Having considered the submissions made by the learned counsel of both sides, this Court is of the opinion that since the petitioner is interested in facing the trial, he should be given adequate opportunities to that effect.
8. Therefore, the prayer of the petitioner is allowed.
9. It is hereby directed that the petitioner, namely **Burhan Uddin** is directed to appear before the trial court within next 10 (ten) days from today in respect of **Special (N) Case No. 37/2025**. On his appearance, the petitioner **Burhan Uddin** shall be released on bail of ₹**50,000/-** (Rupees Fifty Thousand) with a surety of like amount to the satisfaction of the **Special Judge, Sribhumi**.

With the aforesaid direction, the Criminal Revision Petition stands disposed of.
