Heard Mr. M. Sarania, learned counsel appearing for the petitioner.

The petitioner, namely, G.Akanito Assumi @ G. Akanito has filed this application under Section 482 Cr.P.C read with 397/401 of the Code of Criminal Procedure, 1973 for quashing or order dated 21.01.2023 passed in M.R.
