- 1.** Heard Mr. P. A. Ahmed, learned counsel for the applicants/claimants. Also heard Ms. L. Sharma, learned counsel for the respondent/Insurance Company.
- 2.** This interlocutory application has been filed by the applicants/claimants praying for directing the Registry to disburse the 50% of the awarded amount (Rs.8,64,650/-) which has already been deposited by the Insurance Company before the Registry in terms of order dated 28.01.2026 passed in I.A.(C) No. 4095/2025.
- 3.** The learned counsel for the Insurance Company has not objected to the said

prayer. Hence, the prayer is allowed.
