1. Heard Mr. B. D. Das, learned Sr. counsel assisted by Ms. R.Deka, learned counsel for the applicants/appellants. Also heard Ms. K. Das, learned Standing counsel, Elementary Education Department and Mr. R. Borpujari, learned Standing counsel, Finance Department, appearing for the opposite parties/respondents.
2. The present Interlocutory Application is filed seeking condonation of the delay of 481 days in preferring the connected writ appeal against the order dated 02.12.2024 passed by the learned Single Judge in WP(C) No. 5531/2024.
3. Perused the averments made in the application.
4. Learned counsels for the respondents/opposite parties have not

disputed the factual position, inasmuch as under the similar circumstances, a Co-ordinate Bench had already condoned the delay.

5. After going through the averments made at paragraph Nos. 2 (i), 2(ii) & 3 of the application, we are satisfied that good grounds have been assigned by the applicants/appellants for condoning the delay of 481 days in preferring the connected appeal.

6. We, therefore, condone the delay.

7. The Interlocutory Application stands disposed off.

8. Registry to process the appeal and, if the same is found defect free, list the same along with WA No. 388/2025 and Review Petition No. 275/2025 on **12.05.2026** under the appropriate heading.
