Heard Mr. M.K. Hussain, learned counsel for the petitioner.

The petitioner has stated that he is operating a bank account no. 39134083704 at the State Bank of India, Dhupdhara Branch, District - Goalpara. But the respondent bank authorities have put the bank account on hold on the ground that there is a disputed transaction of Rs. 1,500/-. The petitioner has alleged that the account has been blocked without issuing any notice/intimation either by the respondent bank authorities or by any Investigating Agency.

Issue notice, returnable on 08.06.2026.

The petitioner shall take steps for service of notice upon the respondent nos. 1, 2, 4, 5, 6, 7 & 8 by speed post within 3 [three] working days from today.

The learned counsel for the petitioner shall serve a copy of the writ petition along with annexure to the learned Deputy Solicitor General of India [DSGI] for service of notice upon the respondent no. 3 within 3 [three] working days for today.

The name of Government Advocate, Assam is to be deleted from the Cause-List.
