Heard Mr. N.N.B. Choudhury, learned Senior Counsel assisted by Mr. K. Kashyap, learned counsel for the applicant.

The instant interlocutory application has been filed for impleadment of i) Shri Swapneel Paul, District Commissioner, Kamrup (Metro), Hengrabari, Guwahati-781036, Assam, ii) Shri Chinmoy Prakash Phookan, ACS, the Commissioner, Guwahati Municipal Corporation near Ganesh Mandir, Dispur, Guwahati-781006 and iii) Dr. P. Uday Parveen, The Chef Executive (Officer in Charge) Cum Director of Agriculture Marketing Board, Ramkrishna Mission Road, Birubari, P.O. Ulubari, Guwahati-781007, as respondents No.5, 6 and 7 in the connected contempt petition.

It is submitted by the learned counsel for the applicant that the respondents No.1, 2 and 3 in the connected contempt petition have been transferred from their respective posts and the new incumbents i.e. the aforesaid 3(three) officials have joined the respective posts.

Taking into account the facts of the case, the prayer for impleadment of the aforesaid officials in the connected contempt petition is allowed. Petitioner to file the amended cause title in the contempt petition impleading the respondents No.5, 6 and 7 in the arrays of respondents.
