Heard Mr. D Gogoi, learned counsel for the petitioner. Also heard Mr. G Pegu, learned CGC for the respondents.

The petitioner is aggrieved that, without resorting to the medical review as contemplated under the Rules, he is likely to be placed before the Medical Invalidation Board (MIB) and thereafter invalidated out of service. Under such

circumstances, the petitioner is before this Court.

Issue Notice, returnable by 4 (four) weeks.

Since Mr. G Pegu, learned CGC appears and accepts notice on behalf of all the respondents, notices are waived. However, extra copies be furnished to him within 1 (one) week from today.

Mr. G Pegu, learned CGC will obtain required instructions and place it before the Court.

List the matter after 4 (four) weeks.

Meanwhile, in the event, the petitioner is placed before the Medical Invalidation Board (MIB), no final order in respect of invalidation from service shall be passed without the leave of the Court.
