ORDER

Date : 02.06.2023

Heard Mr. R. Ali, learned counsel for the petitioners, Ms. G. Hazarika, learned standing counsel for respondent no.1 and Ms. S. Baruah, learned Govt. advocate appearing for respondent nos. 2 and 3, 5 and 6.

It is submitted that the respondent no.4 is a repetition of respondent no.3.

The learned counsel for the petitioners submits that pursuant to order dated 15.05.2023, he has filed an additional affidavit to bring on record the conditions of Land Allotment Certificate.

Issue notice returnable in 4(four) weeks.

Requisite extra copy of the writ petition be served on the learned State and departmental counsel in course of the day.

The pendency of this writ petition shall not be a bar for the competent respondent authorities to consider the prayer of the petitioners for settlement in terms of allotment certificate issued to the petitioners.

The Court is also inclined to issue notice on the Govt. of Assam through the Chief Secretary to examine this issue because in this case the petitioners had applied for and they were allotted land allotment certificates and as the said process was not brought to its logical conclusion the, petitioners are before this Court. The Court has observed that similar writ petitions are pending before this Court. Therefore, the State is required to examine the reasons of failure on part of the revenue officials to bring the land allotment matters to its logical conclusion, compelling the petitioners to rush to the Court. Therefore, the State through its competent officer shall inform the Court about the measures they

intend to take so as to prevent avoidable litigations to come to Court.

The learned Govt. advocate and learned departmental counsel shall transmit a copy of this order to the competent authorities of the Govt. to bring this order to the notice of the said authority.
