1. We have heard Mr. A.R.Bhuyan, learned Senior counsel assisted by Mr. S. Abdur, learned counsel for the applicant/appellant. Also heard Ms. K. Das, learned Standing Counsel, Education Department and Mr. S. Bora, learned counsel, for the respondents/opposite parties.
2. The present Interlocutory Application has been filed by the applicant/appellant seeking condonation of the delay of **45** days in preferring the connected Writ Appeal against the Order dated 17.02.2025 passed by the learned Single Judge in WP(C) No. 781/2025.
3. Perused the averments made in the application.
