Heard Mr. R. Ali, learned counsel for the petitioner.

Aggrieved by the freezing of the petitioner's bank account, being Account No. 502410110010182 of the Bank of India, Goalpara Branch, in connection with a cybercime case registerd under Nccrp Portal Acknowledgement No. 31903260055894, dated 14.03.2026, at Cyber Police Station, Nagpur City, this writ petition has been instituted.

Issue notice, returnable by 4 (four) weeks.

As Mr. K. K. Parasar, learned CGC, enters appearance and accepts notice on behalf of respondent No. 5/Union of India, issuance of formal notice to the said respondent is dispensed with. However, he shall be furnished with requisite

extra-copy of the petition during the course of the day.
