The instant application under Section 5 of the Limitation Act has been filed praying for condonation of delay of 8(eight) days against the impugned judgment dated 28.12.2023 passed by the learned MACT No.2 Kamrup(M), Guwahati, in MAC Case No. 1902/2019.

2. The learned counsel, Mr. S.P Sharma has entered appearance on behalf of the claimant/respondents and has not raised any objection regarding the prayer for condonation.
