Heard Mr. Niran Borah, learned counsel for the petitioner. Also heard Mr. B. Gogoi, learned counsel, appearing on behalf of respondents No. 1, 2 & 3.

2. By filing this writ petition under Article 226 of the Constitution of India; the petitioner seeks for a direction to the respondent authorities to register him as a Pharmacist and to issue registration certificate in terms of the Pharmacy Act, 1948.

3. The grievance of the petitioner is that though he is a Bachelor in Pharmacy; however, he has been denied registration as a Pharmacist by the authority verbally on the ground that he failed in Physics(Theory) in Higher Secondary level.

4. Issue notice.

5. As Mr. Gogoi, learned counsel has appeared and accepted notice on behalf of respondents No. 1, 2 & 3, no formal notice is required to be issued to the said respondents. However, he shall be furnished with the requisite extra copies of the petition during the course of the day.
