Mr. D. P. Bora, learned Counsel for the respondents, submits that the respondent authorities have sought for a week's further time to place the clarifications as sought for by this Court vide the order dated 06.01.2025. It is to be noted that the petitioner was promoted with retrospective effect to the post of Professor by the respondent authorities vide notification dated 14.11.2012, making such promotion effective from 17.01.2006. However, the consequential benefits flowing to the petitioner has not been released to him. The present matter is pending since the year 2018 and the respondent authorities have not even filed an affidavit in the matter.

In the event the petitioner is not given his due benefits, this Court would consider as to how the petitioner would be required to be compensated in the matter for the denial of benefit due to him since the year 2006, on the next date of listing.

Registry is directed to list this matter again on 23.01.2025.
