The learned counsel for the writ petitioners in these batches of writ petitions have appeared and made their submissions. Mr. R. Mazumder, learned standing counsel, Department of School Education as well as Mr. P. Nayak, learned standing counsel, Finance Department, Assam are present on behalf of official respondents.

It is submitted at the bar the these matters include the writ appeals preferred against the judgment of the learned Single Judge dealing with issues of entitlement of

petitioners under the old pension scheme *vis-à-vis* the new pension scheme and also the claim of school teachers under the OBB scheme. It has been pointed out that grouping/ re-grouping of cases on the basis of subject matters of dispute as well as the relief prayed for would be necessary for final hearing and disposal of these cases.

As such, Registry to verify the records and carryout grouping/ regrouping of the cases after taking necessary inputs from the learned departmental counsel. The learned counsel for the appellants/ writ petitioners would also be at liberty to furnish necessary inputs to the Registry pertaining to their respective cases, including other pending matters connected with this series which have not been listed today.

Needless to say, after analyzing the inputs received from the learned counsel for the parties and on examination of the records, if it transpires that any matter listed today in this series is not required to be dealt with by this specially constituted Division Bench for the reasons to be recorded in writing, those may be segregated and listed before the appropriate Bench.
