Ali, learned counsel represents respondent no.5, whereas Ms. S. Khanikar, learned counsel appears for respondent no.6. None to represent respondent no.1.

List for Motion again on 17.07.2019, as we propose to examine the case records at the first instance.

Office to requisition the case records in respect of (i) F.T. Case No.857/2016 and (ii) F.T. Case No.(F.T. No.8th) 869/2018 from the office of the Foreigners' Tribunal 8th, Goalpara.

As an interim measure, the petitioner Hazarat Ali shall not be taken into custody and deported from the territory of India, subject to the condition that he shall appear before the Superintendent of Police (Border), Goalpara, within 15 (fifteen) days from today and furnish a bail bond of Rs. 5,000/- with one local surety of the like amount to the satisfaction of the said authority. A direction is also made to the Superintendent of Police (Border), Goalpara that as and when the petitioner appears within the period indicated above, the biometrics of the iris of both eyes, the fingerprints of both hands and photograph of the petitioner shall be obtained, whereafter he shall be allowed to remain on bail.
