Heard Mr M U Mondal, learned counsel for the petitioner and Mr S Bhuyan, learned Standing Counsel for Higher Education Department.

2. The case of the petitioner is that he was selected and appointed as a Lecturer in the Department of Education in the Hamidabad College, District-Dhubri, and thereafter, the State Level Scrutiny Committee had recommended the petitioners along with others for provincialization of their services. However, later, it is stated by the learned counsel for the petitioner that the petitioner's case was dropped, but later on, again, the petitioner was recommended for provincialization of her services, but the outcome of the said recommendation was not known to the petitioner and aggrieved thereby, the petitioner has filed this instant petition.

3. Mr Bhuyan, learned Standing Counsel for Higher Education Department, is directed to bring the instructions on record, as to what happened to the recommendation given by the District Level Scrutiny Committee. It is also stated that similar matter is being taken up and fixed on 8th of June, 2026, and a prayer is made to take up this matter along with
