Heard Mr. S. Islam, learned counsel for the applicant/writ petitioner as well as Ms. G. Hazarika, learned counsel representing respondent nos.1 and 4. Mr. A. Kalita, learned counsel appears for respondent nos.3, 5 and 6 whereas Ms. B. Das, learned counsel appears for respondent no.2.

In terms of our earlier order, Mr. A. Kalita, learned State Counsel has obtained necessary instructions and submits that the applicant/writ petitioner may once again appear before the Superintendent of Police (Border), Goalpara along with a suitable bailor for obtaining the benefit of the interim protection granted by this Court vide order dated 18.05.2020 passed in the connected WP(C)/3678/2019, arising out of F.T.2 Case No.251/G/2014 of the Foreigners' Tribunal No.2, Goalpara, Assam.

In view of the above, we direct the applicant/writ petitioner to appear before the Superintendent of Police (Border), Goalpara within 10 (ten) days from today with a suitable bailor. Other conditions made in the aforesaid order dated 18.05.2020 shall remain as it is.

On the above, the Interlocutory Application stands disposed of.
