Heard Mr. Amit Kumar Sharma, petitioner in person. Also heard Mr. K Kalita, learned counsel for the respondents.

The petitioner by way of instituting the present writ petition has presented a challenge to an order dated 05.09.2024, passed by the disciplinary authority, imposing a penalty of fine of Rs.51,000/- upon the petitioner, on conclusion of a departmental proceeding instituted against him.

The petitioner has also assailed an order dated 16.12.2024, passed by the Appellate Authority, rejecting the appeal of the petitioner and thereby, affirming the penalty imposed upon him by the disciplinary authority.

Issue notice, returnable by 6 (six) weeks.

Mr. Kalita, learned counsel accepts notice on behalf of all the respondents. Accordingly, no formal notice is required to be issued.
