ORDER

Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

From a careful perusal of the instant case record, it may be observed that the matter was previously listed before the Lawazima Court on 17.10.2025 and vide the order passed on the said date, the petitioner was directed to take fresh steps for service of notice upon the respondent No. 6 through speed post mode, within 7 (seven) days time from the date of the said order.

Vide the said order, the petitioner was also permitted to file requisite affidavit reflecting the service status of the *dasti notice* dated 23.05.2023 issued to the respondent No. 6.

But so far, no such steps have been taken by the petitioner to comply with the directions of the aforementioned Lawazima Court's order dated 17.10.2025.

In view of the above, the petitioner is afforded further one week time to take fresh steps for service of notice upon the respondent No. 6 by way of speed post mode.

Further, the petitioners are also permitted to file affidavit regarding service of the *dasti notice* dated 23.05.2023 issued to the respondent No. 6.

Let the matter be listed again before the Lawazima Court on 21.01.2026.
