Aggrieved by the freezing of his saving bank account No. 915010057937454 in the Axis Bank Limited, Noonmati, this writ petition is instituted by the petitioner, seeking a direction to allow the petitioner to operate his saving bank account.

The respondent authorities on the report regarding the involvement of disputed transactions amount of Rs.10,000/- and Rs.9,887/-, wherein the said amount was credited to the account of the petitioner on 25.12.2025 and 26.12.2025 from the CCB, Chennai, NCRP Nodal Officer Assistant Commissioner of Police (ACP), the SHO, Bisrakh Police Station in-charge, Cyber Cell, the aforesaid saving account of the petitioner has been frozen.
