**ORDER**

**Date : 09.01.2023**

Case taken up before the Lawazima Court.

Learned counsel Mr. U.N. Chattry appears for the petitioner.

Perused the records.

The office note dated 03.01.2023 reveals that the petitioner has not yet taken fresh steps for service of notice upon respondent Nos. 1, 10, 11, 14, 16, 29, 30 & 32, despite the direction of the previous Lawazima Court vide its order dated 07.12.2022, whereby, the petitioner was directed to take steps by registered post with A/D as well as by registered post with A/D at their correct and proper address.

However, it appears that service reports have been received back in respect of the notice issued by the usual process on 30.07.2022. Upon perusal, **the said service reports reveal that respondent Nos. 1, 19 & 24 has been expired.** As such, the petitioner may take steps for substitution of legal heirs of the respondent Nos. 1, 19 & 24, if so advised.

Further, the aforesaid service report reveals **that notice has been duly served upon respondent Nos. 29, 30 & 32. As such, service is deemed to be completed in respect of the said respondents (respondent Nos. 29, 30 & 32).**

Moreover, it may be mentioned that the petitioner has not yet taken fresh steps upon proforma respondent Nos. 34 to 48, despite the direction of the Hon'ble Court vide its order dated 28.06.2022.

In view of the above, the petitioner is directed to take steps upon respondent Nos. 10, 11, 14, 16 and proforma respondent Nos. 34 to 48 by *Dasti mode*, within 10(ten) days. The steps are to be routed through the Registry and the petitioner is to file an affidavit after effecting service on the aforesaid respondents.

Let the matter be listed again before the Lawazima Court in the first week of February, 2023.
