Heard Mr. W. Rahman, learned counsel for the petitioner.

By filing this petition, the petitioner claims for payment of compensation of Rs. 5 lacs under the Victim Compensation Scheme on account of the alleged kidnapping and murder of the son of the petitioner on 28.11.2021.

The petitioner contended that an application has been submitted on 05.12.2024 to the Assam State Legal Service Authority, Kamrup(M), which has been forwarded to the District Legal Service Authority, Amingaon, which is still under enquiry.

Issue notice, returnable by 4 (four) weeks.
