Heard Ms. M. Choudhury, learned counsel for the appellant.

2. In this appeal, under Section 173 of the MV Act, the appellant has put to challenge the correctness or otherwise of the judgment and award dated 20.02.2026, passed by the learned Member, MACT, Tinsukia (Tribunal hereinafter), in MAC Case No. 21/2022.

3. It is to be noted here that vide impugned judgment and award dated 20.02.2026, the learned Tribunal has awarded a sum of Rs. 9,70,000/- as compensation along with interest @ 6% per annum from the date of filing of the claim petition, till realization.
