Heard Mr. M.U. Mondal, learned counsel for the applicant.

The present interlocutory application has been instituted praying for impleading the Circle Officer, South Salmara Revenue Circle as party respondent in the connected writ petition.

I have considered the contentions made in the present interlocutory application and find that given the nature of grievance raised in the connected writ petition, impleading the Circle Officer, South Salmara Revenue Circle as a party respondent, therein, would facilitate a due and proper adjudication of the issue arising in the connected writ petition.

Accordingly, the prayer of the applicant to implead

“The Circle Officer

as a party respondent No. 8 in the connected writ petition being W.P.(C) No. 4252/2025, stands allowed.
