The petitioner earlier had also instituted Cont.Case(C) No.661/2025 on the same grounds and the said contempt case was closed vide order dated 19.01.2026 by this Court on being apprised that the directions passed by this Court in WP(C).No.735/2025 was complied with by the respondents vide issuance of an order dated 15.12.2025.
