**2.** Upon consideration of the averments as well as on perusal of the relevant documents appended to this contempt petition, let notice be issued upon the alleged contemnors to show cause as to why a proceeding, as required under section 12 of the Contempt of Courts Act, 1971, *read with* Rule 3 & 4 of the Contempt of Court(Gauhati High Court) Rules, 1977 and Article 215 of the Constitution of India should not be initiated against them, for their willful and deliberate violation of this Court's order dated 23.10.2025 passed in WP(c)4151/2017, and/or why such further or other order(s) should not be passed as to this Court may deem fit and proper.

**3.** The notice is made returnable within 4(four) weeks.

**4.** Learned counsel for the petitioners shall take necessary steps for causing service of notice upon the respondents by Speed Post as well as by usual process within a week from today.
