This Court is of the opinion that under the given circumstances, the petitioners deserve to be given interim protection.

Therefore, as an interim measure it is hereby directed that in the event of arrest in connection with Howly P.S. Case No.69/2026, the petitioners, (1). Apiar Hussain @ Apair Hussain, (2). Tota Miah, (3). Muklesur Rahman, (4). Jiyarul Hoque @ Ziaur Rahman, (5). Manjurul Hoque @ Manjurul Alam, (6). Al Main @ Al Amin Junnun, (7). Aminul Hoque, (8). Rinku Ali, (9). Abdul Aziz, (10). Azahar Uddin and (11). Julhash Ali shall be released on bail of Rs.20,000/- each with sureties of like amount to the satisfaction of the arresting authority.
