Heard Mr. A. Sarania, learned counsel for the petitioners.

2. The petitioners claimed to have purchased two plots of land measuring 8 katha 12 chatak 15

gonda covered by Dag No.2 and Patta No.2 and 18 kathas 3 chatak covered by Dag No.3 Patta No.5 at Lathimara Mouza in the district of Cachar. For widening of National High way - 37, respondent authorities have acquired land including the petitioners' land vide notification dated 28.11.2023. However, in the said notification, the names of the petitioners were not mentioned. The name of one Iliyas Ahmed was found to be wrongly mentioned in the said notification, on which, the said Iliyas Ahmed made a prayer before the Additional District Commissioner, (LA branch) clarifying that he has no claim and ownership of the said land.

3. The petitioners having found their names not mentioned in the said notification have approached the authorities for inclusion of their names in the notification.

4. It is contended by the learned counsel for the petitioners that despite the undisputed ownership of the petitioners, the names of the petitioners have not been included without any justifiable reason. Being aggrieved, this petition is instituted.

Issue notice, returnable by 4 (four) weeks.

5. Since Mr. N. Goswami, learned State counsel appears and accepted notice on behalf of respondents No. 6, 7 and 8; Mr. A. Bhattacharjee, learned Standing Counsel, Revenue appears for the respondents No.4 and 5, no formal notice is required to be issued to the said respondents. However, requisite extra copies of the writ petition be furnished to the learned counsel for the respondents within 3 (three) days from today.

6. The learned counsel for the petitioners shall take steps for service of notice upon the respondents No. 1 to 3 by speed post as well as usual process within 3 (three) working days from today.
