Heard Mr. N. Borah, learned counsel for the petitioner.

2. This is an application under Section 24 of the CPC, for transfer of the case being F.C. (Civil) Case No. 478/2026 which is filed under Section 13(1)(i-a) and 13(1)(i-b) of the Hindu Marriage Act read with Section 27(1)(d) of the Special Marriage Act from the Court of Principal Judge, Family Court-1, Kamrup (M), Guwahati to the Court of learned District Judge, Biswanath.

3. The learned counsel for the petitioner has submitted that the parental home of the petitioner is at Tezpur and the marriage was solemnized at Tezpur. It is also submitted that the respondent, who is the estranged husband is working at Nagaon. It is also submitted that petitioner is the only daughter of her parents, who are suffering from ailments and she is taking care of them.

4. Issue notice returnable on 19.06.2026.

5. The petitioner shall take steps within 2 (two) days for service of notice on the respondents by speed post with A/D.

6. The learned counsel for the petitioner is permitted to collect the postal track number and to submit the postal track report prior to the next date of listing.

7. As an interim measure till the next returnable date further proceedings of F.C. (Civil) Case No. 478/2026, pending before the learned

Principal Judge, Family Court-1, Kamrup (M), Guwahati shall remain stayed.

8. The petitioner shall cause production of a certified copy of the order before the said learned Court to make the order effective.
