Heard Mr. U. Choudhury, learned Legal Aid Counsel appearing for the applicant, who submits that by filing this application, the applicant seeks

condonation of 204 days delay in filing the connected appeal against the Judgment dated 08.09.2025 and the Order of Sentence dated 22.09.2025 passed by the Court of the Additional Sessions Judge-cum-Special Judge, POCSO, Kamrup(M), Guwahati in Session Special Case No. 271 of 2024.

Mr. R. R. Kaushik, learned Additional Public Prosecutor, Assam, submits that although he has no objection to the delay but since the matter pertains to conviction under Section 6 of the POCSO Act, notice may go to the informant, at this stage.

In view of above, issue notice, returnable by three (3) weeks.

Mr. R. R. Kaushik, learned Additional Public Prosecutor, Assam, accepts notice on behalf of the State respondent and therefore, no formal notice is required.

The applicant to take steps for service of notice upon the respondent No. 2 (informant), as per the usual procedure through the Office of the Additional Public Prosecutor, Assam. The notice be effected through the jurisdictional Officer-in-Charge of the Police Station concerned and a report to that effect be conveyed back to the Court through to the Office of the Additional Public Prosecutor, Assam.
