Case taken up before the Lawazima Court.

Learned counsel Ms. A. Hussain appears on behalf of the petitioner. Heard.

Perused the records.

Perusal of the recent office note dated 12.08.2025 reveals that notice was issued to the respondent No. 6 by registered post with A/D on 02.06.2025.

But, in respect of the aforesaid notice issued to the respondent No. 6, it appears that neither the A/D card nor any un-served notice has been received by the concerned section till date.

Further, it appears that the postal track consignment details regarding the aforesaid notice issued to the respondent No. 6 has been generated by the concerned section and tagged with the case record at **Flag-'TC'**. The said report shows the status as follows:–

“Article not booked- No booking information found for this article number”.

In view of the observations made above, this Lawazima Court is of the view that service of notice upon the respondent Nos. 6 may be awaited for some time.

Let the matter be listed again before the Lawazima Court on 29.08.2025 with an updated office note reflecting service status of the notice issued to the respondent No. 6 on 02.06.2025.
