Learned counsel Ms. M. Choudhury is present for the Insurance

Company/applicant and learned counsel Mr. T. Roy is present for respondent Nos. 1 to 6/claimant.

It is submitted by both the sides that the Insurance Company and the claimants have amicably settled their dispute and a sum of Rs. 8,30,500/- is to be paid to the claimants by the Insurance Company as full and final satisfaction of the claim arising out of MAC Case No. 56/2019 which was disposed of by the learned Member, MACT, Hailakandi.

After considering the submissions at the Bar with circumspection, the appellant/Insurance Company is directed to deposit an amount of Rs. 8,30,500/- in the MACT, Hailakandi, within 45 days from the date of this order.

The other application registered as I.A. No. 1267/2025 is disposed of allowing the prayer of the applicant to withdraw the statutory amount which was deposited before the Registry of this Court.

In terms of the above observation, both the I.A.'s are disposed of.
