Heard Mr. F.A. Laskar, learned counsel for the petitioners; Mr. A. Bhattacharyya, learned Standing Counsel, Revenue Department for the respondent nos. 1 & 2; and Mr. J. Handique, learned Junior Government Advocate, Assam for the respondent nos. 3 – 7.

2. The petitioners have stated that they are inhabitants of village – Chandipur Grant. the petitioners have approached this Court seeking inter alia a direction to the respondent authorities to restore the land records like Old Chitta Book Volume-3 and Draft Chitta Volume-3 as well as Shofa [grand total] of the Chitta Book of Village Chandipur Grant, Algapur in the district of Hailakandi on the ground that the respondent authorities have projected that the original Chitta Book Volume-3 and Draft Chitta Volume-3 of Village Chandipur Grant, Algapur is missing. The petitioner has also sought for a direction to the respondent authorities to enter their names in the newly constructed Chitta and Jamabandi of Mouza – Chandipur Grant reconstructed as per Order dated 06.03.2024 passed in I.A.[Civil] no. 762/2024 of W.P.[C] no. 3026/2019.

3. Issue notice, returnable on 27.07.2026.

4. As Mr. Bhattacharyya, learned Standing Counsel, Revenue Department has appeared and accepted notice on behalf of the respondent nos. 1 & 2; and Mr. Handique, learned Junior Government Advocate has appeared and accepted notice on behalf of the respondent nos. 3 – 7, issuance of formal notices to the said respondents are dispensed with. However, requisite nos. of extra copies of

the writ petition along with annexures are to be furnished to Mr. Bhattacharyya and Mr. Handique within 2 [two] working days from today.

5. Learned counsel for the parties are also heard on the interim prayer.

6. Considering the projection made by the petitioners that they are holders of pattas in respect of the lands under their occupation, it is provided that till the returnable date, the petitioners shall not be evicted without following due process of law.
