2. By filing this writ petition under Article 226 of the Constitution of India, the petitioner has assailed the impugned opinion dated 23.02.2024, passed by the Member of Foreigners' Tribunal 1st, Nagaon, Assam in F.T. Case No. 7930/12(D) arising out of S.P.(B).Ref. D/Case No. 1376/98, by which the petitioner was declared as an illegal migrant.
