Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

On a perusal of the office note dated 30.09.2024 reveals that notice was issued to the

respondent Nos. 1, 2, 3, 4, 5 & 6 by registered post with A/D on 24.06.2024.

Now, in regard to the aforesaid notice, it appears that the A/D cards of respondent Nos. 2, 3, 4 & 6 have been received by the concerned section bearing the purported signature along with the official seals of the respective respondents. But, in respect of the respondent Nos. 1 & 5, it appears that no A/D cards or un-served notices have been received by the concerned section as of yet.

Further, it may be mentioned that on a careful perusal of the case record, it has been observed that learned counsels of the respondent Nos. 2, 3, 4, 5 & 6 have entered appearance on behalf of them by filing Vakalatnama. Along with the aforesaid, it may be mentioned that learned counsel Ms. S. Mochahari has appeared before the Lawazima Court today on behalf of the respondent No. 6.

In view of the observations made above, it may be said that **service in respect of the respondent Nos. 2 to 6 has been completed.** Next, as far as the respondent No. 1 is concerned, **the petitioner is directed to take fresh steps for service of notice upon the respondent No. 1 by registered post with A/D as well as by usual Court process through the office of the learned Civil Judge (Junior Division), Kamrup (M), within 7 (seven) days.**

As it appears that a mention has been allowed for listing of the instant matter on 03.10.2024, the matter is laid before the Hon'ble Court.
