1. We have heard Mr. V. K. Barooah, learned counsel for the applicant.
2. The present Interlocutory Application has been filed by the applicant seeking striking out the names of the respondent No. 7 and respondent No. 10, from the array of respondents in the connected WP(C) No. 1423/2024.
3. The learned counsel for the applicant submits that there is no adverse or necessary interest involved against the respondent No. 7 and respondent No. 10 in the connected writ petition and accordingly, seeks leave of this Court to strike out the names of the respondent No. 7 and respondent No. 10 from the array of respondents in the connected writ petition.
