Heard Ms. B. Borah, learned counsel for the applicant.

This is an application praying for impleading the present Deputy Commissioner, Kamrup (M) namely, Shri Sumit Sattawan, IAS as party respondent No. 6 in the Cont.Cas(C) No. 520/2017.

It appears from the averments made in the impleading application that during the pendency of this contempt petition, the respondent No. 5, holding the post of Deputy Commissioner, Kamrup (M) has been transferred to the other Department of Government of Assam. Accordingly, it has become necessary to implead the new incumbent to the said post.

It appears that the impleadment sought is essential for the effective adjudication of the contempt proceeding. Accordingly, the impleadment sought stands allowed.

It is directed that the Deputy Commissioner, Kamrup (M) namely, Shri



Sumit Sattawan, IAS be impleaded as party respondent No. 6 in the contempt proceeding.
