Heard Mr. A. H. M. R. Choudhury, learned counsel for the petitioners.

By filing this writ petition, the petitioners have prayed for a direction to the respondent authorities to grant them regular scale of pay in terms of the judgment and order dated 04.10.2024, passed in WP(C) No. 2729/2019.

The petitioners are working as Tutors in various L.P. and M.E. Schools under the Department of School Education, Government of Assam, on a fixed salary of Rs. 10,700/- per month. It is the claim of the petitioner that since they are performing the similar duties and responsibilities as that of the regular teachers, they are entitled to be provided regular scale of pay scale applicable

to regular teachers in terms of the judgment and order dated 04.10.2024, passed in WP(C) No. 2729/2019.

Issue notice, returnable by 4 (four) weeks.

As Ms. N. Phukan, learned Standing Counsel, Elementary Education Department, enters appearance and accepts notice on behalf of all the respondents, no formal notice need be served to the respondents. However, she shall be furnished with requisite extra-copies of the petition.
