The instant application under Section 173 of the MV Act has been preferred by the appellant/claimant praying for enhancement of the award passed in Judgment dated 08.04.2026 in MAC Case No.158/2021 by the learned MACT, North Salmara, Abhayapuri, Bongaigaon, Assam.

2. Heard learned counsel for the appellant, Mr. R. Ahmed.
3. The main ground taken by the appellant herein is that the tribunal while determining the loss of income has failed to consider the IT return of the deceased for the assessment year 2021-2022 but the Tribunal had erroneously considered the I.T return for the assessment year 2020-2021.
4. The learned Tribunal had also awarded the wrong compensation on the other conventional heads also.
5. Admit the appeal, call for the TCR.
