ORDER

1. By order dated 31.07.2019 passed in WP(C) No. 5211/2019, the respondent authorities, more particularly, the respondent No.1 in concert with other official respondents, were directed to consider the claim for provincialisation of the services of the petitioners in terms of the Assam Education (Provincialisation of Services of Teachers and Re-organisation of Education Institution) Act, 2017.

2. Ms. R. B. Bora, learned counsel appearing for the respondent/contemnor No. 2, on instruction, submits that the cases of the petitioners were recommended by the District Level Scrutiny Committee for provincialisation of their services under Resolution No. 6 in its meeting held on 27.10.2017 and the same has been sent to the concerned Department in the Government of Assam, which is having jurisdiction to pass order of provincialisation.

3. This Court has requested Ms. N. Phukan, learned counsel representing the

Elementary Education Department to complete her instruction as regards the fate of such recommendation of the BTC authorities to which, Ms. Phukan, has readily agreed.

4. Copy of this contempt petition along with annexures be furnished to Ms. N. Phukan, learned counsel.

5. Ms. Bora, learned counsel appearing for the respondent/contemnor No. 2, shall also furnish a copy of the communication dated 25.08.2022 issued under the District Elementary Education Officer, Kokrajhar addressed to the Director of Education, BTC, Kokrajhar to Ms. Phukan, learned counsel.

6. List this matter on **02.04.2026**.

7. Registry shall reflect the name of Ms. N. Phukan, learned counsel representing the Elementary Education Department in the cause list henceforth.
