Heard Mr. P.K. Sarma, learned counsel for the accused/ applicants. Also heard Mr. R.J. Baruah, learned APP for the State.

2. This is an application filed under Section 482 of the BNSS, 2023 praying for granting of pre-arrest bail to the accused/ applicants as the accused/ applicants are apprehending arrest in connection with a dispute relating to landlord tenancy issue.

3. The learned counsel appearing for the accused/ applicants submits that there is an existing dispute about landlord tenancy between the accused/ applicants and one Mr. Abu Sahid Md. Zakir Hussain. The learned counsel submits that due to such dispute the accused/ applicant as well as his wife has already filed 2 (two) FIRs before the Dispur Police Station, however, the same were not registered as yet. He submits that due to such filing of the FIR the accused/ applicants are apprehending that an FIR may have also been filed against them as the police is searching for them and calling them to the police station. Having apprehension accused/ applicants have filed the instant AB application.

4. This Court has gone through the contents of the AB application and heard the submissions made by the learned counsels appearing for the respective parties.

5. Taking into account the facts of the case, it is directed that the Officer-in-Charge of Dispur P.S. shall submit a report as to whether any FIR

has been lodged against the accused/ applicants, namely, **Wahidul Amin and Zaheer Akram Bora**, in Dispur P.S. The aforesaid report is to be submitted by the officer concerned to the Office of the Public Prosecutor by 19.06.2026.

6. Till then no coercive action shall be taken against the accused/ applicants.

7. The Registry is directed to hand over a copy of the order to the learned Additional Public Prosecutor.

8. Let the matter be listed on 19.06.2026.
