Heard Mr. P.K Deka, learned counsel for the petitioner. Also heard Mr. S Das, learned standing counsel, Department of Higher Education, Assam appearing for respondent Nos. 1 & 2 Ms. K Borpujari, learned standing counsel, U.G.C appearing for respondent No. 3, Mr. M Ahmed, learned counsel appearing for respondent No. 4, Mr. P.J Phukan, learned standing counsel, Gauhati University, Assam appearing for respondent Nos. 5 & 6 and Mr. I Hassan, learned counsel appearing for the opposite party No. 7/Writ Petitioner.

2. Mr. P.J Phukan, learned standing counsel, Gauhati University, Assam appearing for respondent Nos. 5 & 6 has submitted that an affidavit has been filed by the respondents represented by him today, in the connected Writ Petitions. As such, Registry to trace out the same and tag the said

affidavit along with the records of the case.

3. Mr. I Hassan, learned counsel appearing for the opposite party No. 7/ Writ Petitioner, prays for listing the matter again on 24.02.2026, to enable him to take instructions with regard to the contentions raised in the affidavit filed the respondent nos. 5 & 6.
