Heard Mr. R. Mazumdar, learned counsel for the petitioners; Ms. N. Bordoloi, learned Standing Counsel, Revenue Department for the respondent no. 1; Mr. N. Das, learned Junior Government Advocate, Assam for the respondent nos. 2 – 6; and Mr. B. Das, learned Standing Counsel, APDCL for the respondent no. 7.

2. The petitioners have projected that they settled themselves about five decades earlier on a parcel of Government wasteland at Charuabakhra Jungle Block, Mouza – Chapor, Circle – Chapor, Sub-Division – Balasipara. However, they were evicted therefrom on 08.06.2025. Thereafter, the petitioners submitted a Representation dated 01.12.2025, after their applications for settlement of those parcels of land were rejected, for their rehabilitation in plots of land which are habitable in nature. Stating that the said Representation has

not been given due consideration till date, the petitioners are before this Court.

3. Issue notice, returnable on 03.08.2026.

4. As Ms. Bordoloi, learned Standing Counsel, Revenue Department has appeared and accepted notice on behalf of the respondent no. 1; Mr. N. Das, learned Junior Government Advocate, Assam has appeared and accepted notice on behalf of the respondent nos. 2 – 6; and Mr. B. Das, learned Standing Counsel, APDCL has appeared and accepted notice on behalf of the respondent no. 7, issuance of formal notices to the said respondents are dispensed with. However, requisite nos. of extra copies of the writ petition along with annexures are to be furnished to Ms. Bordoloi, Mr. N. Das and Mr. B. Das within 2 [two] working days from today.
