**ORDER**

Heard Mr. S. K. Goswami, learned counsel for the applicants. Also heard Mr. U. Sarma, learned Standing Counsel, Secondary Education Department, for opposite party No. 1; Ms. N. Choudhury, learned Standing Counsel, BTC, for opposite party Nos. 2, 3 & 4; and Mr. P. Mahanta, learned counsel for the opposite parties/writ petitioners in WP(C) No. 1987/2026.

This is an application seeking impleadment of the applicants as party respondent Nos. 6 to 8 in the connected writ petition, being WP(C) No. 1987/2026.

The petitioners in the connected WP(C) No. 1987/2026 have approached this Court challenging the order dated 12.03.2026, passed by the Secretary, BTC, whereby the recommendation made by the Departmental Promotion Committee, BTC, on 04.03.2024 for promotion to the posts of Head Master/Head Mistress under Baksa District is cancelled and a decision has been taken to conduct a fresh interview pursuant to the decision of this Court in a batch of writ petitions, leading case being WP(C) No. 1735/2024.

The applicants herein were the writ petitioners in the said WP(C) No.1735/2024, wherein they have challenged the recommendation for promotion to the posts of Head Master/Head Mistress dated 04.03.2024. The order dated 12.03.2026, passed by the Secretary, BTC, which is under challenge in the connected writ petition, appears to have been passed pursuant to the directions issued by this Court in the said batch of writ petitions instituted by the present applicants in the earlier round of litigation. Thus, the applicants herein would be the necessary parties in the writ proceedings as the order dated 12.03.2026 has been put to challenge in WP(C) No. 1987/2026.

Having considered that the rights and interests of the applicants are likely to be affected, in the event, any order is passed in the connected writ petition and the dispute concerning promotion to the posts of Head Master/Head Mistress essentially involves competing claims between the opposite parties/writ petitioners and the present applicants, I am of the considered view that the applicants would be necessary parties for the effective and complete adjudication of the issues involved in WP(C) No. 1987/2026. Accordingly, the applicants are allowed to be impleaded as respondent Nos. 6 to 8 in the

connected writ petition, being WP(C) No. 1987/2026.

Interlocutory application stands allowed and disposed of.
