Heard Ms. P. Ahmed, learned counsel for the petitioner, who has put to challenge an order dated 08.04.2025 passed by the District Commissioner, Nalbari whereby the representation submitted by the petitioner on 29.01.2025 has been rejected.

It is the contention of the petitioner that the relevant factors have not been taken into consideration and the rejection is made on irrelevant factors.

Let notice be issued, returnable by 6 (six) weeks.

Ms. G. Hazarika, learned Standing Counsel, Revenue Department accepts notice on behalf of the respondent no. 1 whereas Shri H. Sharma, learned Addl. Senior Government Advocate, Assam accepts notice on behalf of the respondent nos. 2 to 6.

Pendency shall not be a bar for consideration of the application dated 30.04.2025 stated to have been submitted before the District Commissioner, Nalbari.
